**Sub: Intimation under Regulation 30 of the Securities and Exchange Board of India

Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (Listing Regulations), we wish to inform you that the Company has today i.e. April 11, 2025, received an intimation from Western Railway-Ahmedabad Division (Western Railway) whereby the Company has been informed to hand over its Laundry Service Operations located at Coaching Depot- Kankaria, Ahmedabad, Gujarat by April 30, 2025 as its Build-Own-Operate-Transfer (BOOT) contract with Western Railway has concluded.

The above-mentioned contract was earlier awarded to erstwhile Jyothy Fabricare Services Limited (since amalgamated into Jyothy Labs Limited) on November 15, 2011, for a period of ten years which was further extended. Subsequently, by virtue of the aforesaid intimation from Western Railway, the said contract shall now stand concluded on April 30, 2025.

Accordingly, the operations of one of the Dry Cleaning and Laundry Service Units of the Company situated at Kankaria, Ahmedabad, Gujarat (Ahmedabad Unit), operating on BOOT model shall cease with effect from April 30, 2025 at 18:00 Hours.

Further, the disclosure as required under Regulation 30 of the Listing Regulations read with SEBI Master circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 is enclosed herewith as **Annexure A**.
